



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Recommending Noreen "Katy" Aday for the Position of Clinic Director of the Cibecue Indian Health Service Health Clinic)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, Burnette Lupe, a member of the Tribe, representing a number of residents from the community of Cibecue, did this day request that the Tribal Council consider recommending Noreen "Katy" Aday for the position of Clinic Director of the Cibecue Indian Health Service Clinic; and

WHEREAS, Ms. Aday works as a U.S. Public Health Service Commissioned Corps Officer as a social worker, has excellent academic and professional credentials, and is an enrolled member of the White Mountain Apache Tribe; and

WHEREAS, Ms. Aday's contribution to the Tribe have been numerous and far reaching, including her work as a member of the IHS Governing Board where she ensured that the Tribe's health concerns were heard and addressed, development of key protocols that address critical health needs, and her work on the Suicide Prevention Task Force; and

WHEREAS, the Tribal Council finds that the U.S. Indian Health Service has not advised the Tribe as to whether the position of Clinic Director has been filled; and

WHEREAS, the Tribal Council concurs and finds that Ms. Aday is suitable for the position of Clinic Director for the U.S. Indian Health Service Cibecue Clinic.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that:

1. Noreen "Katy" Aday is hereby recommended for the position of Clinic Director for the U.S. Indian Health Service Cibecue Clinic.
2. The U.S. Indian Health Service Phoenix Regional Director is hereby requested to report to the Tribal Council as to the status of the position referenced herein within thirty days of the date of this Resolution.


