

1. Mick Benally - Came on behalf of his daughter Julia Benally and son Mickey Benally, requesting for land in McNary near his resident. The area is big enough for two (2) sites, board approved the request. McDaniel will survey area when approved by council.
2. Chad Altaha – Requesting for land in Hondah area  $\frac{3}{4}$  miles of the smoke shop. Board approved the request.
3. Robin Tessay – Requesting for land in Hondah area  $\frac{3}{4}$  miles of the smoke shop. Board approved the request.
4. Angel Lupe – Requesting for land in Whiteriver area , board approved the request.
5. Arnold Jr. and Roberta Lupe – Requesting for land in Whiteriver on Northside, board approved the request.
6. Victor Edwards – Request for the land in East Fork which belonged to Melody White. This farmland is still in question due to others claiming it and there are no documents. Theresa Paxson came in with Mr Edwards but was told that IvanToggie had given the land back to the Whites because he was told by someone that the land originally belonged to the Whites. 8. Wayne Dazen- Requesting for land in Hondah, board approved the request.
9. Rayburn Dazen – Requesting for land in Hondah, and relinquishing the other site back to tribe. He wants a site closer to the water and electricity line. Board approved both request.
10. Joe Harvey – Came on behalf of his daughter Denise Harvey Johnson requesting for land in Fort Apache. The area he is requesting is being relinquished to Denise by Linda Burnette, but the land belong Rosie Gooday. The board suggested that Mr. Harvey asked for relinquishment from Ms. Gooday. Application on hold.
11. Jarrod Truax – Requesting for land in McNary by the baseball field, board approved the request.
