(Cease radio reports for Chairman, Vice Chairwoman, and Tribal Council)

- WHEREAS,** pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** it is customary for members of the Tribe's governing body to address the general public on radio station KNNB-FM and express their political views; and
- WHEREAS,** due to the Tribe's current financial situation many community members have expressed frustration with the Tribal Council; and
- WHEREAS,** several members of the Tribal Council have received what they have perceived as threats to their persons; and
- WHEREAS,** in an effort to ensure the safety of members of the Tribe's governing body, the Tribal Council should present a unified message to the public; and
- WHEREAS,** the Tribal Council has determined that it is in the best interest of the Tribe that members of the governing body refrain from addressing the general public on radio station KNNB-FM.


BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that all radio reports on KNNB-FM cease for the Chairman, Vice Chairwoman and members of the Tribal Council until February 14, 2009.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.
