

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approval of Land Restoration Projects for Fiscal Year 2008-2009)

- WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS, the Tribal Council of the White Mountain Apache Tribe enacted an ordinance to set aside twenty percent (20%) of the 22 H judgment funds, including income thereon, for the establishment of a perpetual and permanent White Mountain Apache Land Restoration Fund; and
- WHEREAS, no more than eighty percent (80%) of the available income generated from the fund pursuant to the investment policy shall be expended on activities related to land restoration projects; and
- WHEREAS, the Land Restoration Board have selected the projects for the Fiscal year 2008 2009 which are designed to maximize the achievement of long term tribal ecosystem goals and are consistent with Tribal cultural values and concerns; and
- WHEREAS, the Land Restoration Board request the Tribal Council provide final approval for the following projects: North Fork Wetlands, District I Cattle Association, Turkey Creek Cattle Association, Nohwike' Bagowa (Museum and Culture Center), Hydrology and Water Resources, Division of Natural Resources, Ndee Bi' Ni Bida' Illzaahi Project, Tribal Herd, Carrizo Farmland Protection, Canyon Day Livestock Association, Rodeo Chediski Restoration, Land Office Technology Upgrade, and North Fork Livestock Association.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the projects and supporting budgets for the Land Restoration Fund for fiscal year 2008-2008 is hereby approved.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all document necessary to effectuate the intent of this Resolution.

The foregoing resolution was on November 25, 2008, duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (f), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
