



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approval to grant tribal relinquishment request of Elizabeth Cooley)

WHEREAS, tribal member Elizabeth Cooley, dob: 08/13/1996, daughter of Purcell Cooley, Jr. and Phyllis (Jose) Cooley, has requested that her tribal membership with the White Mountain Apache Tribe be relinquished so that she may become eligible for enrollment with the Tohono O'Odham Tribe; and

WHEREAS, the necessary documents of relinquishment of head rights was signed by Purcell Cooley, Jr. in the presence of a Notary Public on April 13, 2009, and are attached hereto and incorporated by this reference; and

WHEREAS, the Tribal Enrollment Committee approved this relinquishment request at their meeting on May 05, 2009.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Elizabeth Cooley and her tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to, hunting, fishing, and recreational privileges upon the Fort Apache Indian Reservation.


BE IT FURTHER RESOLVED by the Tribal Council that it hereby directs the Office of Vital Records to remove Elizabeth Cooley from the membership rolls of the White Mountain Apache Tribe, subject to proof of enrollment by the Tohono O'Odham Tribe within thirty (30) days of the date of this Resolution.

BE IT FURTHER RESOLVED by the Tribal Council that in the event that the Tohono O'Odham Tribe does not provide proof of enrollment to the Office of Vital Records, this Resolution shall be null and void and without force or effect.

The foregoing resolution was on May 12, 2009, duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section II of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

RELINQUISHMENT OF TRIBAL HEAD RIGHTS
WHITE MOUNTAIN APACHE TRIBE
FORT APACHE INDIAN RESERVATION

1, Russell Cooley Jr the parent of our child who is an enrolled member of the WHITE MOUNTAIN APACHE TRIBE, under the age of 15 years, do hereby, of my free will, as an adult over the age of eighteen years, voluntarily and with full knowledge of making this decision, request the TRIBAL COUNCIL of the WHITE MOUNTAIN APACHE TRIBE, WHITERIVER, ARIZONA, to release my/our child from the Tribal Census Rolls of the White Mountain Apache Tribe to enable my/our child to enroll with the Thono O'dadamo Tribe.

Further, I understand that my child will no longer have fishing or hunting privileges on the FORT APACHE INDIAN RESERVATION; No home site or farmland assignments, or claim to have titles to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgment under the Indian Claims Commission Act.

Further, that I must remove from the Fort Apache Indian Reservation within ninety (90) days after the Resolution date accepting my child's relinquishment, any livestock in said child's name. I further understand, however, that my child may reapply for enrollment in the White Mountain Apache Tribe upon reaching the age of eighteen (18), but that the Tribal Council has total, nonreviewable discretion to deny or grant said reapplication.

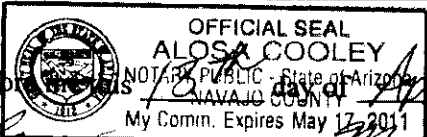
