



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Rescinding Resolution No. 07-2003-200)**


- WHEREAS,** pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** Walk-Through Resolution No. 07-2003-200 was adopted and approved on July 30, 2003, for the relinquishment of Peter Thomas from the White Mountain Apache Tribe to enroll with the Salt River Pima-Maricopa Indian Community; and
- WHEREAS,** Mr. Thomas had advised the Office of Vital Records shortly thereafter that he wished to cancel his relinquishment request and that he wants to remain a member of the White Mountain Apache Tribe; and
- WHEREAS,** despite his request, no action was taken until 2008 when it was discussed by the Tribal Enrollment Committee who approved his request since he was not enrolled with the Salt River Pima-Maricopa Indian Community; and
- WHEREAS,** this matter was brought to the attention of the Tribal Council in March 2009 whereby they stated that he submit a written request (as attached); and
- WHEREAS,** the Tribal Council finds that it is in the best interest of the Tribe to rescind Resolution No. 07-2003-200.


**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby:

1. Rescinds Resolution No. 07-2003-200.
2. Directs the Office of Vital Records to add Peter Thomas to the membership rolls of the White Mountain Apache Tribe.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on May 12, 2009, duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
