**(Approval of Land Board meeting minutes for April 30, 2009)**

**WHEREAS,** pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS,** Raymus Albert, Land Office Director, has come before the Tribal Council this date requesting approval of the Land Board meeting minutes for April 30, 2009; and

**WHEREAS,** the Tribal Council, after reviewing the Land Board meeting minutes, agrees that the Land Board meeting minutes for April 30, 2009 should be approved.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Land Board meeting minutes for April 30, 2009.

The foregoing resolution was on May 19, 2009, duly adopted by a vote of FIVE for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (h), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

Meeting opened in prayer by Pedro Johnson at 9:20 A.M.

1. Lorina Lavender – Requesting for land in McNary near her mother's resident. On 113 N. Cooley Ave. Board approved the relinquishment and the land site application.
2. Ashley McCreery/Olive Gass - Ms. Gass claims that the land that Ms. McCreery got belongs to her, but according to papers it never was in her name. The board approved Ms McCreery to build on that land.
3. Dudra Pinal – Requesting for land that belongs to her father, board approved the request.
4. Anthony Johnson/Clifford Antonio – Mr. Antonio put fence up on the land owned by Mr. Johnson. In 1988 Antoine Antonio had relinquished this to Mr. Johnson but Mr. Antonio and his sister claim that this land is rightfully theirs because their family owned and they were all raised on that land. The board decided for the family to take to court.
5. Deoma Henry/ Sheila Henry – Applying for land in Cibecue, that is being relinquished to her by her sister. Board approved the request.
6. Rose Waters – Inquiring on the land in Rainbow City, (the bean Pot). The papers showed that the 25 years lease has expired.
7. Leon Hawkins – Asking for land in Whiteriver near the youth center, board wants him to talk to Raymus. On Hold.
8. Pauline Armstrong – Requesting for land in Whiteriver, near his fathers Carl Altaha, Baord denied request, she already has land.
9. Jeanette Massey – Requesting for land in Canyon Day, Board approved the request.
10. Raysha Nosie – Applying for land in Hondah homesite. Board approved the request.
11. Olive Gass – Requesting for a different area in Seven Mile, Board approved the request. Relinquising land to her brother Rick V. Gass, boared approved the request.
12. Housing Authority – Requesting for land in Bear Canyon, Stago Pit Apache Dawn, Ft. Apache Junction, East McNary, Board approved the request.

Meeting adjourned at 12:30 PM. Board suggested that we have a meeting in May.
