**(Approval of Land Board meeting minutes for July 31, 2008)**

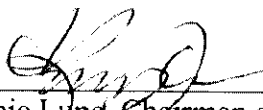

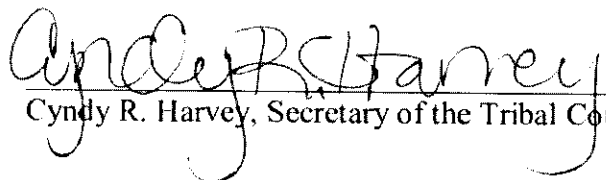

Meeting opened in Prayer by Pedro Johnson at 9:30 A.M.

- ① Delaine Rodriguez – Requesting for land in Dry Valley, McDaniel found an area that is vacant. Board approved the request.
2. Virgilene Wool – Requesting for in Dry Valley, Board approved the request.
3. Florinda Brown – Requesting for land in Hondah behind the smoke shop, board approved the request.
4. Trish Gooday – Requesting for land in Dry Valley, and also if possible 2 acres, the board would like for her to utilize this land first then they can come back and request for more. Board approved the land (1acre).
5. Lela M. Cosen/Rosie Cosen – Came back to settle the landsite agreement in Seven Mile. McDaniel stated that he did go out there and surveyed the according to the old fencing that was up. Raymus stated that when he went out there and talked with Mr. Colelay, he told him which area he wanted to give up to the late Mr. Cosen which was his nephew, so there he sketch out the area which is in the files today. The board approved this request for Ms. Cosen and her daughter.

8. Adrian Colelay – Requesting for land in North Fork area, the area that McDaniel had showed is an area that belonged to Linda Johnson Amos (deceased). The board suggested that a letter be written to Mr. Ritchie at Legal department for recommendation. On hold.
