



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

**(Authorizing Annual Leave Transfer of 80 Hours
From Lowell Walker to Margaret Baha-Walker)**

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, the Tribal Council is aware that Vice-Chairwoman Margaret Baha-Walker's son will co-sponsor a Traditional Sunrise Dance Ceremony; and

WHEREAS, the Tribal Council encourages Tribal Member efforts to advance the Tribe's cultural and heritage appreciation; and

WHEREAS, the Vice-Chairwoman requests the Tribal Council to consider transferring 80 hours of annual leave from Lowell Walker to Margaret Baha-Walker; and

WHEREAS, the Tribal Council finds that it is in the best interest of the Tribe to honor this request for Vice-Chairwoman Margaret Baha-Walker.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves a transfer of 80 hours of annual leave from Lowell Walker to Vice-Chairwoman Margaret Baha-Walker to assist her son with expenses related to his Traditional Sunrise Dance Ceremony.

BE IT FURTHER RESOLVED by the Tribal Council that in the event of any inconsistency between this Resolution and a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all document necessary to effectuate the intent of this Resolution.

The foregoing resolution was on June 24, 2009 duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (h), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
