



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**( Authorizing Funding For Tribal Princess Banquet )**

- WHEREAS,** pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** the Tribal Council of the White Mountain Apache Tribe actively supports tribal members who represent the Tribe on and off the Fort Apache Indian Reservation; and
- WHEREAS,** the White Mountain Apache Princess approached the Tribal Council for financial assistance to pay for a banquet dinner at the Hon-Dah Casino; and
- WHEREAS,** the budget for the Miss White Mountain Apache Princess 2009-2010 was submitted to the Budget Committee for consideration, and is incorporated by reference, action has yet to be taken by the committee regarding an annual budget; and
- WHEREAS,** the Tribal Council believes it is in the best interest of the Tribe to encourage the Tribal Princess in her effort to promote the White Mountain Apache Tribe on and off the Reservation and further provide support by funding her banquet at Hon-Dah.


**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby agrees to allocate \$2,106 in banquet funding for the White Mountain Apache Princess as a show of support and to encourage her best effort in representing the Tribe.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby defers to the Budget and Finance Committee for a recommendation on how to best handle an annual White Mountain Apache Princess budget for the 2009-2010 year.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on July 1, 2009 duly adopted by a vote of SEVEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Section 1 ( a ), ( b ), ( k ), ( s ) ( t ), and ( u ) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
