



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving Non-Member Hunting Regulations 2009-2010)**


- WHEREAS,** pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** the Tribe's Wildlife & Outdoor Recreation Division, (W&ORD), requests the Tribal Council to approve the Non-Member Hunting Regulations for 2009-2010, as attached and incorporated by this reference; and
- WHEREAS,** W&ORD staff advised the Tribal Council that the hunting seasons, bag limits and regulations are based on sound biological principles, surveys and methods; and
- WHEREAS,** the Tribal Council reviewed the recommended Regulations and concurs that they promote sustainable management of Tribal wildlife resources; and
- WHEREAS,** the Tribal Council finds that the Non-Member Hunting Regulations for 2009-2010 are in the best interest of the Tribe because it helps protect the natural resources within the Fort Apache Indian Reservation.


**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Non-Member Hunting Regulations for 2009-2010, as attached and incorporated by this reference, are hereby approved in order to control and properly manage natural resources on the Reservation.

**BE IT FURTHER RESOLVED** by the Tribal Council that in the event of any inconsistency between this Resolution and any prior Resolution or Policy, this Resolution shall govern.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on July 8, 2009, duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

- Arizona Game & Fish, Region 1 office only.
- Arizona Department of Transportation, Hon-Dah & Show Low offices only.

- Clergy and staff from full-time churches permanently located on the Fort Apache Indian Reservation.
- Department of Public Safety, Show Low & Springerville offices only.
- Fort Apache Agency, Bureau of Indian Affairs.
- Hon-Dah Resort/Casino employees.
- Indian Health Services, EMS & Native Air. Whiteriver & Cibecue staff only.
- Navajo County Sheriff's Office, District 3 only (Pinetop, Show Low, Linden & Heber).
- Pinetop Police Department.
- School employees, full-time Fort Apache Indian Reservation schools only.
- Show Low Police Department.
- White Mountain Apache Tribe employees & other full-time reservation store employees.

All Affiliate applicants must provide documented proof of employment.
