**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approving and Requesting that the Bureau of Indian Affairs place the Cibecue Bridge Project FAIR 3(5) on the ARRA, redistribution list of Projects for February 2010)

WHEREAS, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, by Resolution No. 02-2001-44, the Tribal Council of the White Mountain Apache Tribe authorized the Tribal Roads Committee recommend the Bureau of Indian Affairs, Western Region Office place Cibecue Bridge high on the 2009 ARRA priority listing, as it presents an urgent safety need to the community and CBQ school bus route; and

WHEREAS, the Tribal Transportation Committee at a duly convened meeting on June 11, 2009, did approve and recommended that the White Mountain Apache Tribe directs the Bureau of Indian Affairs, Western Region Office place the Cibecue Bridge FAIR 3(5) on the ARRA, Redistribution Projects list for February, 2010 funds; and

WHEREAS, after careful review and consideration, the Tribal Council concurs with the Tribal Transportation Committee's recommendation that the project is in the best interest of the Transportation systems within Fort Apache Indian Reservation and the Tribe.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby requests that the Bureau of Indian Affairs place the Cibecue Bridge Project 3(5) on the 2010 ARRA, Redistribution list of BIA Projects.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all document necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **JULY 9, 2009** duly adopted by a vote of **EIGHT** for and **ZERO** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (h), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
