**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving and Requesting the Bureau of Indian Affairs place the WMAT, Reservation-wide Street Signage Improvement Project on the WMAT, TIP)**

**WHEREAS**, pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS**, the Tribal Transportation Committee recommends that the Tribal Council place the WMAT Reservation wide Street Signage Improvement Project on the Tribe's priority listing, as it presents an urgent unmet safety need in emergency response time by EMT and WMAT and Pinetop Fire Department responders; and

**WHEREAS**, the Tribal Transportation Committee at a duly convened meeting on June 11, 2009, did approve and recommends that the White Mountain Apache Tribe request that the Bureau of Indian Affairs place the WMAT Tribal Reservation wide Streets and Signage Road Improvement Project on the Tribes current TIP utilizing current IRR, Tribal Shares; and

**WHEREAS**, after careful review and consideration, the Tribal Council concurs with the Tribal Transportation Committee's recommendation that it is in the best interest of the Transportation Systems within Fort Apache Indian Reservation and the Tribe.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby requests that the Bureau of Indian Affairs place the WMAT, Tribal Reservation wide Streets Signage Project on the current TIP and approve funds from the current IRR, WMAT, Tribal Shares.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **JULY 9, 2009** duly adopted by a vote of **NINE** for and **ZERO** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (h), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
