



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**( Approving Financial Assistance to Ramondo Henry )**

**WHEREAS,** pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS,** the White Mountain Apache Tribe encourages tribal members to work hard and educate themselves in order to help build and promote the Tribe's economy and culture; and

**WHEREAS,** Ramondo Henry, a tribal member, is a student at the Cibecue High School and he is scheduled to participate in a National Bull Riding Competition in Farmington, NM; and

**WHEREAS,** Ramondo Henry was previously involved in an accident involving school property and has been denied his promised sponsorship for reasons unknown to the Council; and

**WHEREAS,** the Tribal Council finds it in the best interest of the Tribe to approve financial aid in the amount of three hundred dollars (\$300.00) to Ramondo Henry so he may continue competing and representing Cibecue and the Tribe to the best of his ability.


**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves financial assistance to Ramondo Henry for three hundred dollars (\$300.00) in order to support his courage and provide hope after facing a difficult life experience.


**BE IT FURTHER RESOLVED** by the Tribal Council that funding is provided with the understanding that Ramondo Henry absolves the Tribe of any and all liability that may be associated with his event.

**BE IT FURTHER RESOLVED** by the Tribal Council that in the event that this Resolution conflicts with prior Resolutions or Policies, this Resolution shall govern.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on July 15, 2009, adopted by a vote of TEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (g), (k), (t), (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
