



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving Exception to Cost Containment Resolution to Allow for Annual Leave Payout)**


- WHEREAS,** pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** the Tribal Council of the White Mountain Apache Tribe encourages tribal members to educate themselves and the community highly benefits when its people are able to advance their expertise and knowledge base; and
- WHEREAS,** Sylvia Browning is a tribal member and single parent of a daughter who will return to school at the Wisconsin Seminary and requests thirty-two (32) hours of annual leave payout; and
- WHEREAS,** Ms. Browning would use the funds to help pay for the cost of transportation between Whiteriver and Phoenix Airport and also to pay for the extra cost of luggage; and
- WHEREAS,** the Tribal Council, when able, has supported its tribal members and employees during times of need and finds it in the best interest of the Tribe to help Ms. Browning and her daughter bay making an exception to the Cost Containment Resolution and authorizing this request.


**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves thirty-two (32) hours of annual leave payout, making a one-time exception to the Cost Containment Resolution for Ms. Sylvia Browning, for the purpose of promoting education and encouraging tribal members to meet their goals.

**BE IT FURTHER RESOLVED** by the Tribal Council that in the event of any inconsistency between this Resolution and any prior Resolution or Policy, this Resolution shall govern.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on August 19, 2009, duly adopted by a vote of SIX for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
