

## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Issuing Laudine Holly Dahkoshay Hopper a Business License For Buying Aluminum on the Reservation)

WHEREAS, pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache

Tribe, inter alia, the Tribal Council has the authority to represent the Tribe and act in all

matters that concern the welfare of the Tribe; and

WHEREAS, the Tribal Council of the White Mountain Apache Tribe has a constitutional obligation to

manage all economic affairs of the Tribe; and

WHEREAS, Business Development is critical to the economic success and prosperity of the Tribe and Tribal

member entrepreneurs are at the heart of Tribal Business and Economic Development; and

WHEREAS, Laudine Dahkoshay Hopper, a Tribal member, requests the Tribal Council to consider issuing a

Business license so that she may buy aluminum (including cans) on the Reservation; and

WHEREAS, Ms. Dahkoshay Hopper presented the Tribal council with a list of over three hundred Tribal

members who supported her business and appreciated the services she offered the Tribe; and

WHEREAS, the Tribal Council encourages all Tribal members to actively engage in conducting business on

the Reservation and finds that it is in the best interest of the Tribe to issue a business license to

Laudine Holly Dahkoshay Hopper.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that Tribal member Laudine Holly Dahkoshay Hopper is hereby issued a business license and authorized to conduct her aluminum buying business on the Reservation.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>August 31, 2009</u> duly adopted by a vote of <u>SEVEN</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
