



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Authorizing Financial Assistance to Alchesay High School Basketball Program)

- WHEREAS,** pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** the White Mountain Apache Tribe encourages physical education and extra-curricular activities that benefits Apache student health and well-being on the Fort Apache Indian Reservation; and
- WHEREAS,** the Alchesay High School Basketball Program has raised approximately \$1200 and has requested financial assistance from the Tribe in the amount of twenty five hundred (\$2500) dollars to help defray the cost of purchasing new uniforms; and
- WHEREAS,** Rubert Lupe, Sr., in his capacity as Whiteriver Unified School District Educational Board President, has offered to seek reimbursement to recover the price paid for the uniforms; and
- WHEREAS,** the Tribal Council finds that it is in the best interest of the Tribe to assist Alchesay High School and provide its Basketball Program with financial assistance to help purchase new uniforms.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Tribe to provide financial assistance in the amount of two thousand and five hundred (\$2500) dollars to Alchesay High School's Basketball Program for the purpose of buying new uniforms for the team.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Treasurer to use funds from the Ak Chin account for the purposes described hereto.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs Rubert Lupe, Sr., President of the Whiteriver Unified School District's Educational Board, to seek reimbursement from the District for the amount paid to help the Basketball Program purchase new uniforms.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on December 2, 2009 duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (j), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
