



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approval to grant tribal relinquishment request of Hannah Theresa Vavages)

WHEREAS, tribal member Hannah Theresa Vavages, dob: 05/20/1990, daughter of Alvin Vavages and Martha (Kessay) Vavages, has requested that her tribal membership with the White Mountain Apache Tribe be relinquished so that she may become eligible for enrollment with the Gila River Indian Community; and

WHEREAS, the necessary documents of relinquishment of head rights was signed by Hannah Theresa Vavages in the presence of a Notary Public on September 17, 2009, and are attached hereto and incorporated by this reference; and


WHEREAS, the Tribal Enrollment Committee approved this relinquishment request at their meeting on October 27, 2009.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Hannah Theresa Vavages and her tribal membership with the White Mountain Apache Tribe is relinquished, along with any and all privileges accorded members of the White Mountain Apache Tribe such as, but not limited to, hunting, fishing, and recreational privileges upon the Fort Apache Indian Reservation.


BE IT FURTHER RESOLVED by the Tribal Council that it hereby directs the Office of Vital Records to remove Hannah Theresa Vavages from the membership rolls of the White Mountain Apache Tribe, subject to proof of enrollment by the Gila River Indian Community within thirty (30) days of the date of this Resolution.

BE IT FURTHER RESOLVED by the Tribal Council that in the event that the Gila River Indian Community does not provide proof of enrollment to the Office of Vital Records, this Resolution shall be null and void and without force or effect.

The foregoing resolution was on December 2, 2009, duly adopted by a vote of SIX for and ONE against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section II of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

RELINQUISHMENT OF TRIBAL HEAD RIGHTS
WHITE MOUNTAIN APACHE TRIBE
FORT APACHE INDIAN RESERVATION

I, Hannah Vavages, an enrolled member of the WHITE MOUNTAIN APACHE TRIBE, do hereby of my own free will, as an adult over the age of 18 years, voluntarily and with full knowledge of making this decision, request the TRIBAL COUNCIL of the WHITE MOUNTAIN APACHE TRIBE, FORT APACHE INDIAN RESERVATION, WHITERIVER, ARIZONA, to remove me from the Tribal Census Rolls of the White Mountain Apache Tribe to enable me to enroll with the Gila River Tribe.

Further, I understand that once my relinquishment is accepted by Tribal Council Resolution, it will be **TOTAL AND IRREVOCABLE**. I will no longer have fishing or hunting privileges on the Fort Apache Indian Reservation; no rights to homesite or farmland assignments, claim or title to any resources of the WHITE MOUNTAIN APACHE TRIBE, or monies distributed pursuant to Judgment under the Indian Claims Commission Act. Further, that I must remove from the Fort Apache Indian Reservation within ninety (90) days after the resolution date accepting my relinquishment, all my livestock and personal property.
