

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Authorizing Home Site Roads, Inventory and Transportation Improvement Plan)

WHEREAS.

pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS,

the Tribal Transportation Committee unanimously finds and recommends that the White Mountain Apache Tribe include all newly proposed roads that are to be built on the Fort Apache Indian Reservation (FAIR) to also be placed on the FAIR Roads Inventory for future development; and

WHEREAS,

the Tribal Transportation Committee further finds and recommends that the proposed roads be placed on the Transportation Improvement Plan (TIP) for scattered housing locations throughout the Reservation, utilizing the American Recovery and Reinvestment Act of 2009 (ARRA) for Housing Funds as shown below in Exhibit A:

after careful consideration, the Tribal Council finds that the Tribal Transportation Committee's recommendation is in the best interest of the Tribe and further finds that the Tribe should adopt the scattered housing plan along with the associated proposed roads to be funded by the American Reinvestment Recovery Act; and

WHEREAS,

given the urgency of the request, the Tribal Council further finds that this needs to be considered and made outside of its regularly scheduled meeting; and

WHEREAS,

the Tribal Council further finds that: (1) this Resolution may be voted upon by signature of a member of the Tribal Council where a signature indicates a vote for this Resolution, (2) the Tribal Council Secretary should attempt to obtain signatures for members of the Tribal Council personally, (3) no signature would mean that the respective Tribal Council member is against this Resolution, (4) the Tribal Council Secretary should wait no longer than a reasonable period of time to obtain a vote by signature or by no signature and so indicate that this Resolution was presented to the respective member of the Tribal Council for a vote.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that due to impending deadlines, this Resolution qualifies as an Emergency Resolution and is therefore eligible for consideration outside of the Tribal Council's regularly scheduled meeting.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that given the urgency of the request described herein, this Resolution may be voted upon as follows: (a) by signature of a member of the Tribal Council, including the Chairman of the Tribal Council and the Vice-Chairwoman of the Tribal Council, where a signature indicates a vote for this Resolution, (b) the Tribal Council Secretary shall attempt to obtain signatures for members of the Tribal Council personally, (c) no signature shall mean that the respective Tribal Council member is against this Resolution, (d) the Tribal Council Secretary should wait no longer than a reasonable period of time to obtain a vote by signature or by no signature, and so indicate that this Resolution was presented to the respective member of the Tribal Council for a vote.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby document necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>January 6</u>, 2010, duly adopted by a vote of <u>SEVEN</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (c), (m), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
