

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approving Preparation of McNary Town Park Rules and Regulations)

- WHEREAS, pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS, this day Consoni Hill came before the Tribal Council and described the many problems that McNary Park has with people smoking and drinking around kids, dumping trash, graffiti and vandalism due to the fact that the park is located close to the roadway; and
- WHEREAS, Consoni Hill presented examples of park rules currently being used in Pinetop/ Lakeside and proposed that similar rules be created for McNary Park in order to better regulate usage of the park; and
- WHEREAS, Assistant Tribal Attorney Fred Soto suggested that an Ordinance for McNary Park Rules be prepared, with Legal Department assistance, and be resubmitted to the Tribal Council for review and posting; and
- WHEREAS, it was suggested that McNary Park be a test area for the new rules and regulations, and if the rules are successful in McNary, they may later be applied to all Tribal parks; and
- WHEREAS, the Tribal Council reviewed Consoni Hill's suggestion thoroughly and determined that it is in the best interest of the Tribe that Park Rules and Regulations be developed for McNary Park, in Ordinance form, and that the matter come back before the Tribal Council for review and posting.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby agrees that it is in the best interest of the Tribe that rules and regulations be developed for McNary Park, in Ordinance form with Legal Department assistance, and that the matter come back before the Tribal Council for final review and posting.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.
