



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

( **Authorizing Financial Assistance for Rhonda Quintero** )

**WHEREAS,** pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS,** the Tribal Council of the White Mountain Apache Tribe, when able, helps to support its Tribal Members during times of need; and

**WHEREAS,** Rhonda Quintero, a member of the Tribe, has encountered financial difficulties due to medical obligations related to her mother, Violet Quintero, who is currently residing in a nursing home in Globe, Arizona; and

**WHEREAS,** Rhonda Quintero requests financial assistance to pay for housing expenses; and


**WHEREAS,** the Tribal Council of the White Mountain Apache Tribe finds it in the best interest of the Tribe to help Rhonda Quintero by providing financial assistance in the amount of six hundred (\$600.00) dollars to pay for housing expenses for Violet Quintero.


**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Business Office to provide financial assistance to Rhonda Quintero in the amount of six hundred dollars (\$600.00) to pay for housing expenses for her mother, Violet Quintero.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on January 14, 2010 duly adopted by a vote of TEN for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
