



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Authorizing a Business License for Fort Apache Home Maintenance)

- WHEREAS,** pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** Tribal Member Marco Minjarez desires to open and operate a business in the Fort Apache community to be known as "Fort Apache Home Maintenance; and
- WHEREAS,** the business will employ experienced carpenters, plumbers, and other trade workers who will be available to deliver quality and affordable maintenance services to residents and businesses within the vicinity of the Fort Apache Indian Reservation; and
- WHEREAS,** the Tribal Employment Rights Office has been consulted and has offered to assist the Fort Apache Home Maintenance business by referring individuals needing employment; and
- WHEREAS,** Marco Minjarez wishes to be allowed to utilize the payroll deduction system set up through the Tribe's business office, which will enable tribal employees to pay for needed maintenance and construction services on their homes; and
- WHEREAS,** Marco Minjarez has ensured the Tribal Council that he focus solely on maintenance and will not perform work that would normally require a licensed contractor, i.e. electrical, plumbing, structural walls, until Fort Apache Home Maintenance is properly licensed to do such work in the State of Arizona; and
- WHEREAS,** the Tribal Council of the White Mountain Apache Tribe feels that it is in the best interest of the Tribe to promote entrepreneurship amongst Tribal Members and concurs with this request.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that:

1. Tribal member Marco Minjarez, is hereby authorized and issued a business license to operate and conduct a business identified as "Fort Apache Home Maintenance" in the Fort Apache community.
2. Voluntary payroll deductions will be made available to employees of the White Mountain Apache Tribe to pay for services conducted by "Fort Apache Home Maintenance". The implementation of this process shall be handled by "Fort Apache Home Maintenance", along with the Tribe's payroll supervisor.

BE IT FURTHER RESOLVED by the Tribal Council that in the event of any inconsistency between this Resolution and any prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **MARCH 3, 2010** duly adopted by a vote of **SEVEN** for and **ZERO** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (h), (o), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
