



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving Appointments to the Tribal Enrollment Committee)**


- WHEREAS,** pursuant to Article IV, Section 1(a) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** the Tribal Council Secretary has informed the Tribal Council of the White Mountain Apache Tribe that there are several vacancies on the Enrollment Committee; and
- WHEREAS,** Tribal Elders Mrs. Dorinda Crocker, Chairperson, Mrs. Minnie Burnette and Mrs. Veronica Bead have resigned from their positions on the Enrollment Committee; and
- WHEREAS,** the Tribal Council thanks these elders for their dedicated service to the Tribe; and
- WHEREAS,** the active members of the Enrollment Committee recommend that Mr. Wesley Loas and Mrs. Lilly Davenport fill the vacancies, with future candidates to be considered by the Tribal Council; and
- WHEREAS,** the Tribal Council finds that the recommendation of the Enrollment Committee is in the best interest of the White Mountain Apache Tribe and therefore Mr. Wesley Loas and Mrs. Lilly Davenport should be placed on the Enrollment Committee; and
- WHEREAS,** the Tribal Council further finds that the remaining Enrollment Committee vacancies should be filled with the following individuals: Mrs. Bernice Caddo, Mrs. Victoria Brewer, and Mr. Wayne Colelay, Jr.


**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby appoints Mr. Wesley Loas, Mrs. Lilly Davenport, Mrs. Bernice Caddo, Mrs. Victoria Brewer, and Mr. Wayne Colelay, Jr. to serve on the Enrollment Committee effective immediately.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event of any inconsistency between this Resolution and any prior Resolution or Policy, this Resolution shall govern.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairwoman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

This Resolution was on March 16, 2010, duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to authority vested in it by Article IV, Sec. 1, (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
