



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving Certification of the General Election Results)**

**WHEREAS,** Article VI of the Tribal Constitution of the White Mountain Apache Tribe requires regular elections to be held for Tribal Council; and

**WHEREAS,** pursuant to Article VI, Section 8 of the Tribal Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council adopted an Election Ordinance which mandates that a General Election be held on the first Wednesday of April during an election year, established by Article VI, Section 1 of the Tribal Constitution; and

**WHEREAS,** said General Election was held by the White Mountain Apache Tribe on Wednesday, April 7, 2010, wherein Tribal Council candidates who were certified to the Tribal Council on February 3, 2010, submitted their names to a vote of the people for Chairman, Vice-Chairman and for Council Offices in Districts I, II, III and IV; and

**WHEREAS,** the Tribal Election Commission has certified to the Tribal Council of the White Mountain Apache Tribe that the General Election is complete and has been carried out in accordance with provisions of the Tribal Constitution and the Election Code of the White Mountain Apache Tribe, and has certified that out of 8,987 eligible voters a total of 5,646 ballots were cast, the following number of votes were received by the individuals listed below whose names were on the ballot for the following offices:

**DISTRICT III:** Kino Torino




