



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approving Child Enrollment of Sanaa Wilson)


- WHEREAS,** pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** the Enrollment Committee, on April 27, 2010, held an emergency enrollment meeting to determine the eligibility of Sanaa Wilson for Tribal Member status; and
- WHEREAS,** although she is not yet enrolled, Sanaa Wilson meets the criteria required under the Tribal Constitution and Enrollment Code to become a Tribal Member of the White Mountain Apache Tribe; and
- WHEREAS,** the process was previously held up over the Enrollment Committee's concern that a paternity may be needed to determine eligibility; and
- WHEREAS,** after further review, the Enrollment Committee finds that Sanaa Wilson is eligible to become a Tribal Member and recommends that the Tribal Council approve her membership with the Tribe; and
- WHEREAS,** the Tribal Council finds it in the best interest of the child and the White Mountain Apache Tribe to approve Sanaa Wilson's Tribal Membership, daughter of Lakoya Walker and James Wilson and granddaughter to Bernadine Hastings-Walker.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves Tribal Membership for Sanaa Walker, child of Lakoya Walker and James Wilson and also granddaughter to Bernadine Hastings-Walker.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chair man, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on May 6, 2010, duly adopted by a vote of 10 for and 0 against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
