

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Authorizing Business License for Ronald Josay to Remove Metals from Fort Apache)

WHEREAS, pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, the White Mountain Apache Tribe encourages its Tribal Members to engage in all forms of entrepreneurial activity, including private ventures and self-employment; and

WHEREAS, Ronald Josay, a Tribal Member, is self-employed and seeks to remove recyclable metals, including junk vehicles and old appliances such as refrigerators, stoves, washers, dryers and freezers from the Fort Apache Indian Reservation; and

WHEREAS, Mr. Josay has discussed environmental regulation issues with Terry Hill and has advised the Tribal Council that he will remove chemical materials carefully and further abide by all rules and regulations set forth by the Tribe; and

WHEREAS, the Tribal Council finds it in the best interest of the White Mountain Apache Tribe to approve a Business License for Ronald Josay to conduct hauling of recyclable metals off of the Reservation for his personal business.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves a Business License for Tribal Member Ronald Josay for the purpose of hauling recyclable metals off of the Fort Apache Indian Reservation for his private business.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that as a condition of authorizing the Business License, Ronald Josay agrees to follow all environmental regulations and any and all applicable rules and regulations set forth by the Tribe.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby waives any associated business license fees due the Tribe.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.
