



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Appointing Council Member Cline Griggs to the Riverside Indian Boarding School Board)


- WHEREAS,** pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** the Tribal Council supports the advancement of education among its Tribal Members and is aware that several vacancies exist that should be remedied in the interest of furthering the Tribe's overall educational goals; and
- WHEREAS,** the Tribal Council considered the vacancy existing on the Sherman Indian School Board and filled it per *Resolution No. 05-2010-129*; and
- WHEREAS,** the Tribal Council concludes that the Riverside Indian Boarding School would also benefit from a White Mountain Apache Tribe Board member in order to better represent the interests of the Tribe and its students; and
- WHEREAS,** Tribal Council member Cline Griggs, Sr., was the former Director of Education and meets the requirements necessary for Board membership to adequately represent the Tribe and WMAT students attending the Riverside Indian Boarding School; and
- WHEREAS,** the Tribal Council finds it in the best interest of the White Mountain Apache Tribe to appoint Cline Griggs, Sr., to represent the Tribe's interests on the Riverside Indian Boarding School located in Anadarko, Oklahoma.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby appoints Council Member Cline Griggs, Sr., to the School Board of the Riverside Indian Boarding School in Anadarko, Oklahoma, so that he may represent the Tribe and its students to the best of his ability.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on MAY 27, 2010 duly adopted by a vote of EIGHT for and ZERO against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
