



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Resolution in Support of Submittal of the Proposed IRR-funded Tribal Priority Projects Listing)

- WHEREAS,** pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** the WMAT Transportation Committee duly appointed by the Tribal Council is authorized to advise and recommend to the Tribal Council in all policy and program matters related to the Indian Reservation Roads Program, bridges, roads and highways within the Fort Apache Indian Reservation, byways and trails; and other inter-modal initiatives for the benefit of the members of the White Mountain Apache Tribe; and
- WHEREAS,** the WMAT Transportation Committee is further authorized to interact, meet, and represent the Tribe in such matters with outside agencies such as the Bureau of Indian Affairs, Federal Highway Administration, Arizona Department of Transportation; also local, state, federal governments and other transportation groups, associations, and committees concerning transportation policies, procedures and funding related to but not limited to 25 CFR 170 et. Seq. regarding primary rules, regulations and federal funding initiatives; and
- WHEREAS,** the Tribal Transportation Committee requests that the Tribal Council of the White Mountain Apache Tribe approve the inclusion of the following projects into the Tribes priority listing:

Proposed Roads Priority Listings for WMAT Proposed 2011, 2012, 2013 and 2014 future IRR funding allocations.

- 35 Tribal Headquarters parking lot. R/W, Inventory, TIP & PS&E for curb, gutter and paving.
- 36 W. Cypress St. IR/W, Inventory, TIP & PS&E for curb, gutter and paving.
- 37 W. One Step Beyond St. R/W, Inventory, TIP, PS&E for curb, gutter and paving.
- 38 W. Ponderosa St. R/W, Inventory, TIP and PS&E for curb, gutter and paving.
- 39 W. Ponderosa St. Commercial St., parking lot and office complex. R/W, Inventory, TIP & PS&E for street paving.
- 40 Commercial Street new street behind the commercial center to W. FATCO Rd. R/W, Inventory, TIP & PS&E for curb, gutter and street paving. Also to include all commercial center adjacent parking lots.
- 41 Commercial Street in front of the commercial center to Game and Fish. R/w, Inventory, TIP & PS&E for street paving. Also to include paving of the adjacent parking lots.
- 42 E. Horse Shoe Drive @ Rick Lupe fire Center Inventory, TIP, PS&E for curb, gutter and paving.


WHEREAS, the Transportation Committee requests that the Tribal Council of the White Mountain Apache Tribe approve the proposed Tribal project updates.



BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **JUNE 2, 2010** duly adopted by a vote of **TEN** for and **ZERO** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
