



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving Appointment of Blaine Nosie as Fair and Rodeo Manager)**


- WHEREAS,** pursuant to Article IV, Section 1(a) and (s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and to appoint subordinate committees, commissions, boards, advisory or otherwise; and
- WHEREAS,** there is a need to appoint a new Fair & Rodeo Manager to prepare for the 2010 White Mountain Apache Tribal Fair & Rodeo; and
- WHEREAS,** the Fair & Rodeo Manager is responsible for setting up and managing the event as well as closing out the operation and maintaining the records for the event; and
- WHEREAS,** Blaine Nosie has been nominated to serve as Fair & Rodeo Manager through the conclusion of the 2010 WMAT Fair & Rodeo season; and
- WHEREAS,** the Tribal Council believes that the appointment of Blaine Nosie is in the best interest of the Tribe and the 2010 WMAT Tribal Fair & Rodeo.


**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby appoints Blaine Nosie to serve as Fair & Rodeo Manager through the end of the 2010 WMAT Fair & Rodeo season.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **JUNE 2, 2010** duly adopted by a vote of **NINE** for and **ZERO** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
