



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Issuing Limited Waiver of Resolution 03-1995-95 for Tribal Youth Camp Instructors)**

- WHEREAS,** pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** *Resolution No. 03-1995-95* requires a “full background” check of anyone visiting the Fort Apache Indian Reservation for the purpose of dealing with children; and
- WHEREAS,** the full background check requirement helps to ensure the safety of Tribal member children while under adult supervision; and
- WHEREAS,** the Tribal Council was informed by members of the White Mountain Apache Police Department that a summer camp for at-risk youth will be held at the Williams Creek Boys Camp beginning Monday June 7, 2010; and
- WHEREAS,** due to the short notice, the Police Department has been unable to perform a “full background” check on adult counselors, as a full check would take several months; and
- WHEREAS,** the Tribal Council was informed that a preliminary background check has been performed on all the adult counselors and that some Law Enforcement Officers will be present at all times during the camp; and
- WHEREAS,** the Tribal Council feels that it is in the best interest of the Tribe to provide a limited waiver of the “full background” check requirement of *Resolution No. 03-1995-95* for the summer camp for at-risk youths taking place at the Williams Creek Boys Camp beginning on June 7, 2010.


**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby grants a limited waiver to the “full background” check requirements of *Resolution No. 03-1995-95* for the summer camp for at-risk youths at the Williams Creek Boys Camp beginning June 7, 2010.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.
