



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Approval for Tribal Departments & Employees to Assist the Fair & Rodeo Office)

- WHEREAS,** pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** the Fair and Rodeo Manager and Commissioners are currently organizing the festivities for the 2010 Tribal Fair and Rodeo with limited funding; and
- WHEREAS,** renovation and repair of facilities for the Tribal Fair and Rodeo are required for reasons of appearance and safety; and
- WHEREAS,** a successful Tribal Fair and Rodeo requires safe facilities and a positive public image for the Tribe and for thousands of visitors attending the Tribe's Annual Fair and Rodeo; and
- WHEREAS,** it has been recommended that Tribal Departments and Enterprises waive all fees for the renovation and repair of the Fair and Rodeo facilities; and
- WHEREAS,** the waiver includes the cost of materials and labor, as needed, to complete all renovations and repairs; and
- WHEREAS,** the Tribal Council finds it in the best interest of the Tribe to waive all fees for the Tribal Fair and Rodeo Office.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs all Tribal Departments to waive all fees for equipment, labor and services for the Tribal Fair and Rodeo.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby encourages Tribal Departments to assist in the renovation and repairs of the Tribal Fair and Rodeo facilities.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.


