



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Appointing the School Board of the Theodore Roosevelt School)**

**WHEREAS,** pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

**WHEREAS,** the White Mountain Apache Tribal Council has heard the concerns of several parents of students attending the Theodore Roosevelt School (TRS) and their feelings towards the members of the School Board; and

**WHEREAS,** Resolution 07-2010-203 removed all existing members of the Theodore Roosevelt School Board; and

**WHEREAS,** it has been recommended that the Tribal Council remove the existing members and replace them with the following members of the Parental Advisory Committee: Cheyanne Burnette, Michael Patterson, Enola Tenijieth and a parent from the Havasupai Tribe to be named later.


**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby places the following individuals on the TRS School Board: Cheyanne Burnette, Michael Patterson, Enola Tenijieth, and a parent from the Havasupai Tribe to be named later.


**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that Roberta Leslie shall remain in her position as a Liaison to the Tribal Council but shall not be a voting member of the School Board.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on JULY 27, 2010 duly adopted by a vote of **TEN** for and **ZERO** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (s), (t), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
