

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Request for Job Training Funds for Fort Apache Heritage Foundation, Inc.)

- WHEREAS, pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS, and the majority of the facilities of the Fort Apache/Theodore Roosevelt School historic district have been placed under the administrative care of the Fort Apache Heritage Foundation, Inc. (the Foundation); and
- WHEREAS, and the Foundation is charged with preserving, restoring and rehabilitating the historic district to, in part, provide cultural and heritage tourism-based economic development to benefit the White Mountain Apache Tribal community; and
- WHEREAS, and there exists the need for the completion of significant historic preservation, restoration, and rehabilitation work at Fort Apache and on other historic buildings throughout the White Mountain Apache Tribe's Trust Lands; and
- WHEREAS, and there exists the need to provide training for White Mountain Apache Tribal community members in the preservation, rehabilitation, and adaptation of historic buildings to complete the necessary work; and
- whereas, and the Office of Indian Energy and Economic Development (IEED) was established within the Office of the Secretary, Indian Affairs, U.S. Department of the Interior to provide high-level support for the Department of Interior's goal of serving tribal communities by helping tribes stimulate job creation and economic development; and
- WHEREAS, and the IEED has funding available to support such job training; and
- WHEREAS, the Foundation has the capacity to provide such job training to community members and has provided to the Tribal Council a Plan of Work and Budget for said job training; and
- WHEREAS, the Tribal Council finds it in the best interest of the White Mountain Apache Tribe to request for Job Training Funds for the Fort Apache Heritage Foundation, Inc.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the request of up to \$50,000 from the Office of Indian Energy and Economic Development of the U.S. Department of the Interior through the P.L. 93-638 contracting process for historic preservation job training.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>SEPTEMBER 27, 2010</u> duly adopted by a vote of <u>SEVEN</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (g), (h), (i), (j), (k), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
