



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Modification to Sunrise Park Resort Personnel and Wages Effective September 29, 2010)

- WHEREAS,** pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** Sunrise Park Resort is important to the continued economic development of the White Mountain Apache Tribe; and
- WHEREAS,** management and operation of Sunrise Park Resort is critical to its success; and
- WHEREAS,** certain management decisions have recently had negative impacts on Sunrise Park Resort's success; and
- WHEREAS,** Tribal Council considered the personnel managing Sunrise Park Resort and determined that Marilyn Lovato should be demoted to the position of Assistant General Manager and be paid at a rate of \$45,500.00 per year; and
- WHEREAS,** Ronnie Peaches should be promoted to the position of General Manager and be paid at a rate of \$47,000.00 per year; and
- WHEREAS,** Bill London's wages as Mountain Manager should be adjusted to the rate of \$45,000.00 per year; and
- WHEREAS,** Myra Wagner's wages as head of Advertising should be adjusted to the rate of \$45,000.00 per year; and
- WHEREAS,** each of the individuals are qualified for the positions above and the pay is commensurate with the demands and skill required for each position; and

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby demotes Marilyn Lovato to the position of Assistant General Manager for the Sunrise Park Resort and sets her wages at the rate of \$45,500.00 per year;

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby promotes Ronnie Peaches to the position of General Manager for the Sunrise Park Resort and sets his wages at the rate of \$47,000.00 per year;

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby adjusts Bill London's wages as the Mountain Manager for the Sunrise Park Resort to the rate of \$45,000.00 per year;

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby adjusts Myra Wagner's wages as the head of Advertising for the Sunrise Park Resort to the rate of \$45,000.00 per year;


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on September 29, 2010 duly adopted by a vote of ten for and zero against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (i), (k), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
