

## RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

## (Approval for Transfer of Nursery Property)

WHEREAS, pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, in December of 2008, a propane explosion at the McNary greenhouse caused considerable damage to the existing McNary Nursery structure; and

WHEREAS, the White Mountain Apache Tribe using a generous grant is breaking ground to build and operate a new, state of the art Native Plant Nursery facility; and

WHEREAS, some of the equipment from the McNary greenhouse can be used to support the new nursery facility; and

WHEREAS, the BIA wishes to transfer title to the salvageable equipment and the White Mountain Apache Tribe wishes to take ownership of the salvageable equipment from the McNary Nursery; and

WHEREAS, the Tribal Council finds that it is in the best interests of the Tribe to transfer any salvageable equipment at the McNary Nursery from the BIA to the White Mountain Apache Tribe for use in the new Native Plant Nursery facility.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby approves the Memorandum of Understanding transferring the salvageable equipment at the McNary Nursery from the BIA to the White Mountain Apache Tribe.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>OCTOBER 13, 2010</u> duly adopted by a vote of <u>TEN</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (f), (h), (i), (j) and (u) of the Constitution of the Tribe, ratified by the
