



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

**(Authorization for Agreement Between Head Start and the Child Care Program to
Provide Early Childhood Development Services for 2010-2011 School Year
and Summer Lab Program)**

WHEREAS, pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, the White Mountain Apache Head Start Program ("Head Start") and the White Mountain Child Care Development Program ("Child Care Program") both provide valuable early childhood development services to children of the White Mountain Apache Tribe; and

WHEREAS, Head Start and the Child Care Program will collaborate their efforts for 2010-2011 school year with respect providing quality early childhood development services, determining eligibility and enrollment for the programs and maintaining records for the use of Child Care Development Funds (CCDF); and

WHEREAS, Head Start and the Child Care Program have also teamed up to provide a six week Summer Lab Program to promote early childhood development, the Child Care Program and Head Start will work together to implement the 2011 Summer Lab Program by sharing resources and administering enrollment; and

WHEREAS, the 2011 Summer Lab Program will be held June 12, 2011 to July 22, 2011; and

WHEREAS, Head Start and the Child Care Program are therefore authorized to agree to collaborate services for the 2010-2011 school year and are authorized to agree to establish procedures for implementing the 2011 Summer Lab Program.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes Head Start and the Child Care Program to enter into an agreement to provide quality early childhood development services, determine eligibility and enrollment for the programs and maintaining records for the use of Child Care Development Funds (CCDF) for the 2010-2011 school year.


BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes Head Start and the Child Care Program to enter into an agreement to establish procedures for implementing the 2011 Summer Lab Program.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on **OCTOBER 27, 2010** duly adopted by a vote of **EIGHT** for and **ZERO** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
