

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approval to grant tribal relinquishment request of Manuel Villa)

- WHEREAS, pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS, pursuant to the Enrollment Code and the Tribal Constitution, the Tribal Enrollment Committee is designated to ensure that all requirements are met by each applicant who wishes to relinquish their tribal membership with the White Mountain Apache Tribe; and
- WHEREAS, Tribal Member, Manuel Villa, has requested that his tribal membership with the White Mountain Apache Tribe be relinquished so that he may become eligible for enrollment with the Salt River/Maricopa Indian Community; and
- WHEREAS, the Relinquishment of Tribal Head Rights form has been completed and signed by Manuel Villa in the presence of a Notary Public on October 19, 2010 (see attached); and
- **WHEREAS,** the Tribal Enrollment Committee reviewed and approved this relinquishment request at a duly called meeting on October 25, 2010; and
- WHEREAS, the Tribal Council concurs with the recommendation of the Tribal Enrollment Committee that the relinquishment from tribal membership be approved for Manuel Villa.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of **Manuel Villa**, along with any and all privileges accorded to members of the White Mountain Apache Tribe such as, but not limited to, hunting, fishing, and recreational privileges upon the Fort Apache Indian Reservation.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Office of Vital Records to remove **Manuel Villa** from the membership rolls of the White Mountain Apache Tribe, subject to proof of enrollment by the *Salt River/Maricopa Indian Community* within thirty (30) days of the date of this resolution.

BE IT FURTHER RESOLVED by the Tribal Council that in the event that the *Salt River/Maricopa Indian Community* does not provide proof of enrollment of **Manuel Villa** to the Office of Vital Records, this resolution shall be null and void and force or effect.

Resolution No. <u>12-2010-313</u>

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>December 01, 2010</u> duly adopted by a vote of <u>EIGHT</u> for and <u>TWO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).

RELINQUISHMENT OF TRIBAL HEAD RIGHTS WHITE MOUNTAIN APACHE TRIBE FORT APACHE INDIAN RESERVATION

, Manuel D Villa, an enrolled member of the WHITE MOUNTAIN
APACHE TRIBE, do hereby of my own free will, as an adult over the age of 18 years,
voluntarily and with full knowledge of making this decision, request the TRIBAL
COUNCIL of the WHITE MOUNTAIN APACHE TRIBE, FORT APACHE INDIAN
RESERVATION, WHITERIVER, ARIZONA, to remove me from the Tribal Census Rolls
of the White Mountain Apache Tribe to enable me to enroll with the Saltniver Pina
Mancopa Indian Community.
Further, I understand that once my relinquishment is accepted by Tribal Council
Resolution, it will be TOTAL AND IRREVOCABLE. I will no longer have fishing or
hunting privileges on the Fort Apache Indian Reservation; no rights to homesite or
farmland assignments, claim or title to any resources of the WHITE MOUNTAIN APACHE
TRIBE, or monies distributed pursuant to Judgment under the Indian Claims Commission
Act. Further, that I must remove from the Fort Apache Indian Reservation within ninety
(90) days after the resolution date accepting my relinquishment, all my livestock and
personal property.
