



**RESOLUTION OF THE
WHITE MOUNTAIN APACHE TRIBE OF THE
FORT APACHE INDIAN RESERVATION**

(Authorizing Wilberta George to Receive Annual Leave Transfers from Tribal Employees)

- WHEREAS,** pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and
- WHEREAS,** the Tribal Council of the White Mountain Apache Tribe respects and supports family values and appreciates the fact that there are personal emergencies that come up that are beyond the control of Tribal employees; and
- WHEREAS,** Erma Adley, a Tribal Member employee, informed the Tribal Council of the need to transfer annual leave to her daughter, Wilberta George; and
- WHEREAS,** numerous tribal employees (see attached) have also agreed to contribute their accumulated annual leave hours to Ms. George at the beginning of the upcoming year; and
- WHEREAS,** the Tribal Council finds it in the best interest of Wilberta George and the Tribe to help during this time of need by allowing Wilberta George to immediately receive 241 annual leave hours from Erma Adley.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that:

1. Erma Adley is authorized to transfer 241 annual leave hours respectively to Wilberta George to help cover her annual leave hours as discussed.
2. Effective January 2011, the following employees are authorized to transfer annual leave hours, as specified: Jefferson Cheney Sr. (30 hours), Robert Vataha Jr. (8 hours), Glenn Cromwell Jr. (15 hours), Evalene Tulene (20 hours), David Kitcheyan (20 hours), Sharon Adley (40 hours), Jonah Beach Jr. (40 hours), Wilbert Dale (30 hours), and Mariddie Craig (8 hours).



BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.
