

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approving the 2011 Ceremonial Sunrise Dance Schedule)

WHEREAS, pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, the Tribal Council Secretary maintains a schedule of Sunrise Dance Ceremonies on a yearly basis to make sure that no inconsistencies occur between the Sponsoring families with periodic changes; and

WHEREAS, the Secretary presented a detailed schedule that reflects the information provided by the Sponsoring families; and

WHEREAS, the Sunrise Dance schedule needs to be printed in the Fort Apache Scout; and

WHEREAS, the Tribal Council finds it in the best interest of the White Mountain Apache Tribe to honor and adopt the 2011 Sunrise Dance schedule, attached and incorporated by reference, to facilitate the Sunrise Dance process for the benefit of all involved participants, subject to changes throughout the year.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby declares the attached Sunrise Dance schedule as the official Tribal Council sanctioned 2011 Ceremonial Sunrise Dance schedule of the White Mountain Apache Tribe, subject to changes and amendments throughout the year.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>FEBRUARY 3, 2011</u> duly adopted by a vote of <u>NINE</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (g), (h), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
