

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approval to Grant Tribal Relinquishment Request of Raisa Krista Snow Kitcheyan)

WHEREAS, pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, pursuant to the Enrollment Code and the Tribal Constitution, the Tribal Enrollment Committee is designated to ensure that all requirements are met by each applicant who wishes to relinquish their tribal membership with the White Mountain Apache Tribe; and

WHEREAS, Tribal Member, Raisa Krista Snow Kitcheyan, has requested that his tribal membership with the White Mountain Apache Tribe be relinquished so that he may become eligible for enrollment with the San Carlos Apache Tribe; and

WHEREAS, the Relinquishment of Tribal Head Rights form has been completed and signed by Raisa Krista Snow Kitcheyan in the presence of a Notary Public on December 09, 2010 (see attached); and

WHEREAS, the Tribal Enrollment Committee reviewed and approved this relinquishment request at a duly called meeting on February 02, 2011; and

WHEREAS, the Tribal Council concurs with the recommendation of the Tribal Enrollment Committee that the relinquishment from tribal membership be approved for Raisa Krista Snow Kitcheyan.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of **Raisa Krista Snow Kitcheyan**, along with any and all privileges accorded to members of the White Mountain Apache Tribe such as, but not limited to, hunting, fishing, and recreational privileges upon the Fort Apache Indian Reservation.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Office of Vital Records to remove **Raisa Krista Snow Kitcheyan** from the membership rolls of the White Mountain Apache Tribe, subject to proof of enrollment by the San Carlos Apache Tribe within thirty (30) days of the date of this resolution.

BE IT FURTHER RESOLVED by the Tribal Council that in the event that the San Carlos Apache Tribe does not provide proof of enrollment of **Raisa Krista Snow Kitcheyan** to the Office of Vital Records, this resolution shall be null and void and force or effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>February 2, 2011</u> duly adopted by a vote of <u>Nine (9)</u> for and <u>Zero (0)</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
