

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approving Emergency Enrollment of Minor Child Kaida N. Flores)

WHEREAS, pursuant to Article IV, Section 1(a) and 1(s) of the Constitution of the White Mountain Apache Tribe, *inter alia*, the Tribal Council has the authority to represent the Tribe and act in all matters that concern the welfare of the Tribe; and

WHEREAS, the Tribal Council of the has been informed that Kaida N. Flores, a minor child of Tribal Member Sasha Nachu, is eligible for enrollment as a member of the White Mountain Apache Tribe ("Tribe"); and

WHEREAS, normally, the Enrollment Committee convenes to determine whether the eligibility criteria has been met prior to the Tribal Council endorsing enrollment of a prospective Tribal Member; and

WHEREAS, Kaida's mother, a Tribal Member, informed the Tribal Council that due to personal circumstances and pending legal issues, time is of the essence, and the Tribal Council should consider the child's eligibility for enrollment outside of the normal schedule; and

WHEREAS, although not yet enrolled, Kaida N. Flores meets the criteria required under the Constitution and Enrollment Code to become a member of the White Mountain Apache Tribe; and

WHEREAS, the Tribal Council finds it in the best interest of the child and the Tribe to approve of the enrollment of Kaida N. Flores as a new member of the White Mountain Apache Tribe.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby approves Tribal Membership for Kaida N. Flores, child of Sasha Nachu, provided that the office of Vital Records determines that the child meets all eligibility requirements per the Tribal Constitution and Enrollment Code.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.
