

#### RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

( Approval to Grant Tribal Relinquishment Request of Four Tribal Members )

WHEREAS,

four Tribal members have requested that their tribal membership with the White Mountain Apache Tribe be relinquished so that they may become eligible for enrollment with another Tribe:

Joshua Duwayne Narcho Danielle Marie Tessay Darrell Dean Tessay Jr. Celane Annelda Wright

; and

WHEREAS,

the Relinquishment of Tribal Head Rights form has been completed and signed by each individual in the presence of a Notary Public (see attached); and

WHEREAS,

the Tribal Enrollment Committee reviewed and approved this relinquishment request at a duly called meeting; and

WHEREAS,

the Tribal Council concurs with the recommendation of the Tribal Enrollment Committee that the relinquishment from tribal membership should be approved for the above mentioned individuals.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby grants the tribal relinquishment request of Joshua Duwayne Narcho, Darrell Dean Tessay Jr., Danielle Marie Tessay, and Celane Annelda Wright, along with any and all privileges accorded to members of the White Mountain Apache Tribe such as, but not limited to, hunting, fishing, and recreational privileges on the Fort Apache Indian Reservation.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs the Office of Vital Records to remove the above mentioned individuals from the membership rolls of the White Mountain Apache Tribe.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall govern.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Vice Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution.

The foregoing resolution was on <u>SEPTEMBER 28, 2011</u> duly adopted by a vote of <u>FIVE</u> for and <u>ONE</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
