

RESOLUTION OF THE WHITE MOUNTAIN APACHE TRIBE OF THE FORT APACHE INDIAN RESERVATION

(Approving Certification of General Election Results)

- WHEREAS, Article VI of the Tribal Constitution of the White Mountain Apache Tribe requires regular elections to be held for Tribal Council; and
- WHEREAS, pursuant to Article VI, Section 8 of the Tribal Constitution, the Tribal Council adopted an Election Ordinance which mandates that a General Election be held on the first Wednesday of April during an election year, established by Article VI, Section 1 of the Tribal Constitution; and
- WHEREAS, the General Election was held by the White Mountain Apache Tribe on Wednesday, April 4, 2012, wherein Tribal Council candidates who were certified to the Tribal Council on February 2, 2012, submitted their names to a vote of the people for Council Offices in Districts I, II, III and IV; and
- WHEREAS, the Tribal Election Commission has certified to the Tribal Council of the White Mountain Apache Tribe that the General Election is complete and has been carried out in accordance with provisions of the Tribal Constitution and the Election Code of the White Mountain Apache Tribe, and has certified that of the total of 4,420 ballots cast, the following number of votes were received by the individuals listed below whose names were on the ballot for the following offices:

DISTRICT I: (Cibecue/Oak Creek/Grasshopper)

- **WHEREAS**, a true copy of the Election Commission Certification of Election Results is attached and incorporated by this reference; and
- **WHEREAS**, the Tribal Council accepts the Certification of the General Election Results presented by the Tribal Election Commission.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that pursuant to Chapter 5 of the Tribal Election Code, the Certification of General Election Results submitted by the Tribal Election Commission for the Office of Council Representative for Districts I, II, III and IV is hereby accepted and the attached Certification of General Election Results is hereby incorporated into this resolution by reference.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Tribal Council positions which were the subject of this election shall be filled as follows:

DISTRICT I: Arnold Beach, Sr.

DISTRICT II: Kino Kane

DISTRICT III: Alvin Declay, Sr.

DISTRICT IV: Theresa Moody Larzelere

The foregoing resolution was on <u>APRIL 5, 2012</u> duly adopted by a vote of <u>SEVEN</u> for and <u>THREE</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (i), (s), (t) and (u) of the Constitution of the Tribe, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
