



**RESOLUTION OF THE  
WHITE MOUNTAIN APACHE TRIBE OF THE  
FORT APACHE INDIAN RESERVATION**

**(Approving Certification of General Election Results)**

**WHEREAS**, Article VI of the Tribal Constitution of the White Mountain Apache Tribe requires regular elections to be held for Tribal Council; and

**WHEREAS**, pursuant to Article VI, Section 8 of the Tribal Constitution, the Tribal Council adopted an Election Ordinance which mandates that a General Election be held on the first Wednesday of April during an election year, established by Article VI, Section 1 of the Tribal Constitution; and

**WHEREAS**, the General Election was held by the White Mountain Apache Tribe on Wednesday, April 4, 2012, wherein Tribal Council candidates who were certified to the Tribal Council on February 2, 2012, submitted their names to a vote of the people for Council Offices in Districts I, II, III and IV; and

**WHEREAS**, the Tribal Election Commission has certified to the Tribal Council of the White Mountain Apache Tribe that the General Election is complete and has been carried out in accordance with provisions of the Tribal Constitution and the Election Code of the White Mountain Apache Tribe, and has certified that of the total of 4,420 ballots cast, the following number of votes were received by the individuals listed below whose names were on the ballot for the following offices:

**WHEREAS**, an automatic recount, pursuant to Section 5.5A of the Election Code, with prior notice to the candidates, was held for the District IV race which confirmed the results contained herein; and

**WHEREAS**, a true copy of the Election Commission Certification of Election Results is attached and incorporated by this reference; and

**WHEREAS**, the Tribal Council accepts the Certification of the General Election Results presented by the Tribal Election Commission.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that pursuant to Chapter 5 of the Tribal Election Code, the Certification of General Election Results submitted by the Tribal Election Commission for the Office of Council Representative for Districts I, II, III and IV is hereby accepted and the attached Certification of General Election Results is hereby incorporated into this resolution by reference.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Tribal Council positions which were the subject of this election shall be filled as follows:
