


WHITE MOUNTAIN APACHE TRIBE

A Sovereign Nation Exercising Self-Governance Over the Fort Apache Indian Reservation

Resolution No. 05-2012-34

(Approval of White Mountain Apache Tribe's Road Inventory Update)

- WHEREAS, the Tribal Council of the White Mountain Apache Tribe ("Tribe") is entrusted by the Tribe's Constitution to act in all matters that concern the welfare of the Tribe, to manage all economic affairs and enterprises of the Tribe, and to regulate subordinate organizations for economic and other purposes; and
- WHEREAS, the duly appointed Transportation Committee represents and advises the Tribal Council of the White Mountain Apache Tribe regarding Federal, State, and local issues related to transportation and transportation facilities, addresses current issues and policy matters regarding new laws and regulations as they pertain to tribal transportation, Indian Reservation Road (IRR) Program, and monitors such funding priorities through the Federal Lands Highways Administration (FLHA) and Bureau of Indian Affairs (BIA); and
- WHEREAS, Congress authorized funds for federal-aid highways, highway safety programs, and transit programs and for other purposes under the Safe, Accountable, Flexible, Efficient Transportation Equity Act: A Legacy for Users or SAFETEA-LU, wherein the Indian Reservation Roads (IRR) Program would be administered under both the Federal Lands Highways Administration and the Bureau of Indian Affairs pursuant to Final Rules established in 25 USC Part 170 for Indian Tribes; and
- WHEREAS, Section 442 of 25 CFR Part 170 (effective 10/01/04), hereinafter referred to as "Rule" describes the Indian Reservation Roads (IRR) Inventory as a comprehensive database of all transportation facilities eligible for IRR Program funding; and
- WHEREAS, the Rule describes the significance of continuously updating the database of the IRR Inventory and adding proposed facilities to it through procedures provided at Sections 170.443 and 170.444; and
- WHEREAS, the White Mountain Apache Tribe (WMAT) has a Long-Range Transportation Plan (LRTP) for its Indian Reservation Roads (IRR) highway improvements and construction program dependent on the update of Traffic Counts and Inventory Update; and
- WHEREAS, the transportation Committee is delegated the responsibility to oversee and direct the inventory of all IRR data, mapping and descriptors, and other information related to the development of the LRTP for final review and approval of the Tribal Council of the White Mountain Apache Tribe; and
- WHEREAS, the Transportation Committee has reviewed the attached listing of routes for addition into the IRR inventory and thereby recommends that the Tribal Council accept this inventory update listing and authorize the data for these routes to be encoded into the IRR inventory database and submitted to BIADOT prior to the July 15, 2012 deadline.



BE IT FURTHER RESOLVED that the Tribal Council of the White Mountain Apache tribe does hereby approve the modification of the Tribe's IRR inventory to include the routes contained on the attached list, and authorizes the Bureau of Indian Affairs, Western Regional Office, Division of Transportation, to take the necessary action to update BIADOT's IRR inventory database to incorporate changes and additions pursuant to 25 CFR part 170 as referenced.

BE IT FUTHER RESOLVED that the Tribal Council of the White Mountain Apache tribe does hereby amend Section 3.3.9.2 of the 2007 Fort Apache Indian Reservation - 20 Year Transportation Plan to include the routes shown on the attached list.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, this Resolution shall be declared null and void and have no legal effect. This Resolution shall not be subject to Judicial Interpretation, only the Tribal Attorney, with the assistance of the Tribal Council Secretary, may opine on Tribal Council intent and the meaning of the language as used herein.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Acting Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution. In the event that the Chairman fails to delegate signatory authority to an Acting Chairman, the Vice-Chairman may sign provided that the Tribal Secretary and a Tribal Attorney attest to the veracity of the subject matter of this Resolution.

The foregoing resolution was on <u>May 7, 2012</u> duly adopted by a vote of <u>TEN</u> for and <u>ZERO</u> against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (c), (s), (t) and (u) of the Tribal Constitution, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
