

## WHITE MOUNTAIN APACHE TRIBE

A Sovereign Nation Exercising Self-Governance Over the Fort Apache Indian Reservation

## **Resolution No. 06-2012-80**

(Funding 4th of July Celebration in Cibecue)

WHEREAS, the Tribal Council of the White Mountain Apache Tribe ("Tribe") has on this day received a request by the community of Cibecue for \$10,000.00 to host a 4<sup>th</sup> of July celebration, as set forth by Cibecue Community Board representatives Xena Cromwell, Wayne Ivins and Clifford Dehose, Jr.; and

WHEREAS, the Tribal Council recognizes the Tribe's dire financial situation, however, also recognizes the importance of the federal holiday, Independence Day, and after much deliberation, determines that it is in the best interest of the Tribe to authorize the Treasurer to release up to \$8,000.00 in increments as needed to prepare for and conduct a 4<sup>th</sup> of July celebration in Cibecue.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby authorizes the Treasurer to provide up to \$8,000.00 of funding to Cibecue Community Board members for the purpose of promoting the Cibecue 4<sup>th</sup> of July celebration for the benefit of all Tribal members and the greater White Mountains region.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that the payments may be made in increments to alleviate any potential financial concerns that may arise from such payment.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, this Resolution shall be declared null and void and have no legal effect. This Resolution shall not be subject to Judicial Interpretation, only the Tribal Attorney, with the assistance of the Tribal Council Secretary, may opine on Tribal Council intent and the meaning of the language as used herein.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Acting Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution. In the event that the Chairman fails to delegate signatory authority to an Acting Chairman, the Vice-Chairman may sign provided that the Tribal Secretary and a Tribal Attorney attest to the veracity of the subject matter of this Resolution.

The foregoing resolution was on June 12, 2012 duly adopted by a vote of SIX for and ZERO against and ONE abstention by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (k), (s), (t) and (u) of the Tribal Constitution, ratified by the Tribe on September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
