Resolution No. 10-2012-154

(Appointing Law & Order Committee Members)

WHEREAS, the Tribal Council of the White Mountain Apache Tribe ("Tribe") is entrusted by the Tribe's Constitution to act in all matters that concern the welfare of the Tribe, to manage all economic affairs and enterprises of the Tribe, and to regulate subordinate organizations for economic and other purposes; and

WHEREAS, the Tribal Council of the White Mountain Apache Tribe had in the past created a Law and Order Committee and delegated to it the authority to hear complaints against the Law Enforcement departments and the Judicial system and to bring those complaints to the Council for redress; and

WHEREAS, the Tribal Council of the White Mountain Apache Tribe felt that it was in the best interest of the Tribe to remove all previous members of the Law and Order Committee, as set forth in Resolution No. 10-2012-153; and

WHEREAS, the Tribal Council wishes to appoint Mona Elandro, Romeo Dazen, Dustin Benivedes, Chris Feller and Ruben Kessay to serve on and assume the duties of the Law & Order Committee.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby appoints Mona Elandro, Romeo Dazen, Dustin Benivedes, Chris Feller and Ruben Kessay to serve on and assume the duties of the White Mountain Apache Law and Order Committee.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that pursuant to the cost containment resolution and other cost saving measures instituted by the Tribal Council, the Law and Order Committee members shall not be paid meeting pay or other compensation for their service to the Tribe.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, this Resolution shall be declared null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Acting Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution. In the event that the Chairman fails to delegate signatory authority to an Acting Chairman, the Vice-Chairman may sign.


The foregoing resolution was on **OCTOBER 3, 2012** duly adopted by a vote of **SIX** for and **THREE** against by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (s), (t) and (u) of the Tribal Constitution, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
