

# WHITE MOUNTAIN APACHE TRIBE

A Sovereign Nation Exercising Self-Governance Over the Fort Apache Indian Reservation

## **Resolution No. 01-2013-31**

### (Approving the 2013 Ceremonial Sunrise Dance Schedule)

WHEREAS, the Tribal Council of the White Mountain Apache Tribe ("Tribe") is entrusted by the Tribe's Constitution to act in all matters that concern the welfare of the Tribe, to manage all

economic affairs and enterprises of the Tribe, and to regulate subordinate organizations for

economic and other purposes; and

WHEREAS, the Tribal Council Secretary maintains a schedule of Sunrise Dance Ceremonies on a

yearly basis to make sure that no inconsistencies occur between the Sponsoring families

with periodic changes; and

WHEREAS, the Secretary presented a detailed schedule that reflects the information provided by the

Sponsoring families; and

WHEREAS, the Tribal Council finds it in the best interest of the White Mountain Apache Tribe to honor and adopt the 2013 Sunrise Dance schedule, attached and incorporated by reference, to

facilitate the Sunrise Dance process for the benefit of all involved participants, subject to

changes throughout the year.

**BE IT RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby declares the attached Sunrise Dance schedule as the official Tribal Council sanctioned 2013 Ceremonial Sunrise Dance schedule of the White Mountain Apache Tribe, subject to changes and amendments throughout the year.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, this Resolution shall be declared null and void and have no legal effect.

**BE IT FURTHER RESOLVED** by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Acting Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution. In the event that the Chairman fails to delegate signatory authority to an Acting Chairman, the Vice-Chairman may sign.

The foregoing resolution was on <u>JANUARY 30</u>, <u>2013</u> duly adopted by a vote of <u>SEVEN</u> for and <u>ZERO</u> against with <u>ZERO</u> abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV,

Section 1 (a), (g), (h), (s), (t) and (u) of the Tribal Constitution, ratified by the Tribal September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
