Resolution No. 03-2013-55

(Postpone Transportation Plan To Ensure It is in Final Form)

WHEREAS, the Division of Health Director, Charlene Hamilton, did on this day present a Transportation to the Tribal Council that is consistent with the wishes of the Council and that would address some of the problem areas that have arisen with respect to non-emergency medical transportation; and

WHEREAS, after much discussion, the Tribal Council determined that it would be in the Tribe's and their own best interest to postpone a vote on the adoption of the Transportation Plan so that any necessary amendments needed to address all Tribal concerns be included in the final product and to make sure that all members of the governing body have had time to read and understand the policies as presented.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby determines that the Client Business Office and Division of Health should return to the Tribal Council the following month with a finished and final product for consideration and adoption of Transportation regulations as they pertain to non-emergency medical transportation.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, this Resolution shall be declared null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Acting Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution. In the event that the Chairman fails to delegate signatory authority to an Acting Chairman, the Vice-Chairman may sign.

The foregoing resolution was on **March 13, 2013** duly adopted by a vote of **EIGHT** for and **ZERO** abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (i), (s), (t) and (u) of the Tribal Constitution, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
