Resolution No. 03-2013-77

(Providing Support for Upcoming 2013 Cedar Creek Fair and Rodeo Event)

WHEREAS, the Tribal Council of the White Mountain Apache Tribe (“Tribe”) is entrusted by the Tribe’s Constitution to act in all matters that concern the welfare of the Tribe, to manage all economic affairs and enterprises of the Tribe, and to regulate subordinate organizations for economic and other purposes; and

WHEREAS, the Tribal Council recently authorized the community of Cedar Creek to conduct a pow wow and rodeo in 2013, and agreed that the event may take place concurrently with other high profile events on the Fort Apache Indian Reservation (“Reservation”); and

WHEREAS, after receiving input, Councilman Kino Kane comes now before the Tribal Council on behalf of the community of Cedar Creek, to request that an event, “The 2013 Cedar Creek Community Pow Wow & Rodeo,” be officially recognized and supported by the Tribal Council; and

WHEREAS, because the Tribe is unable to fully fund the event, the community would welcome the Tribe’s support in the form of in-kind contributions as follows:

1. Land Operations to provide heavy equipment to prepare and maintain the rodeo grounds for scheduled events.
2. Tribal Maintenance to repair the announcer’s stand at the fairgrounds.
3. Chairman to issue a letter on behalf of the Tribe requesting that the BIA complete its Road Project in the Cedar Creek area in order to ensure the safety and smooth operations of the Pow Wow and Rodeo event.
4. Utility Authority to repair the water line at the Cedar Creek fairgrounds.
5. Public Works to provide a Water Truck to clear and prepare the fairground area for scheduled events.
6. EMS should be directed to have a presence for the duration of the event.
7. Law Enforcement Officer(s) should be placed on site to complement the security that will be hired for the event.
8. Tribal Treasurer to allocate \$6,000.00 for financial support, using a voucher system for payments due; and

WHEREAS, the Tribal Council finds it in the best interest of the Tribe to provide the support, where available, to help make the Cedar Creek Pow Wow and Rodeo event a success.

BE IT RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that all Tribal enterprises, departments, agencies and the Chairman as referenced herein shall provide assistance to the community of Cedar Creek in order to help the event coordinators to present the best Pow Wow and Rodeo possible. The following directives should be adhered to where financially feasible and provided that no agency or enterprise of the Tribe is unduly burdened by the requests:

1. Land Operations shall provide heavy equipment to prepare and maintain the rodeo grounds for scheduled events.
2. Tribal Maintenance shall repair the announcer's stand at the fairgrounds.
3. Chairman shall issue a letter on behalf of the Tribe requesting that the BIA complete its Road Project in the Cedar Creek area in order to ensure the safety and smooth operations of the Pow Wow and Rodeo event.
4. Utility Authority shall repair the water line at the Cedar Creek fairgrounds.
5. Public Works shall provide a Water Truck to clear and prepare the fairground area for scheduled events.
6. EMS shall have a presence for the duration of the event for safety reasons.
7. Law Enforcement shall place one officer minimum on-site to complement the security that will be hired for the event.
8. Tribal Treasurer shall allocate up to \$6,000.00 by way of a voucher system to provide financial assistance for the event.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event that this Resolution conflicts with a prior Resolution or Policy, this Resolution shall supersede and govern over the conflicting subject matter.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that it hereby directs that in the event this Resolution directly conflicts with the Tribal Constitution, Tribal Ordinances or Federal Laws, this Resolution shall be declared null and void and have no legal effect.

BE IT FURTHER RESOLVED by the Tribal Council of the White Mountain Apache Tribe that the Chairman, or in his absence, the Acting Chairman, is hereby authorized to execute any and all documents necessary to effectuate the intent of this Resolution. In the event that the Chairman fails to delegate signatory authority to an Acting Chairman, the Vice-Chairman may sign.


The foregoing resolution was on MARCH 19, 2013 duly adopted by a vote of SEVEN for and ZERO against and ZERO abstentions by the Tribal Council of the White Mountain Apache Tribe, pursuant to the authority vested in it by Article IV, Section 1 (a), (b), (h), (k), (s), (t) and (u) of the Tribal Constitution, ratified by the Tribe September 30, 1993, and approved by the Secretary of the Interior on November 12, 1993, pursuant to Section 16 of the Act of June 18, 1934 (48 Stat. 984).
